THE PROBLEM

- **CONGESTION: SOLANA'S PERFORMANCE IS LIMITED DURING HIGH TRAFFIC, LEADING TO NETWORK BOTTLENECKS AND DOWNTIME.**

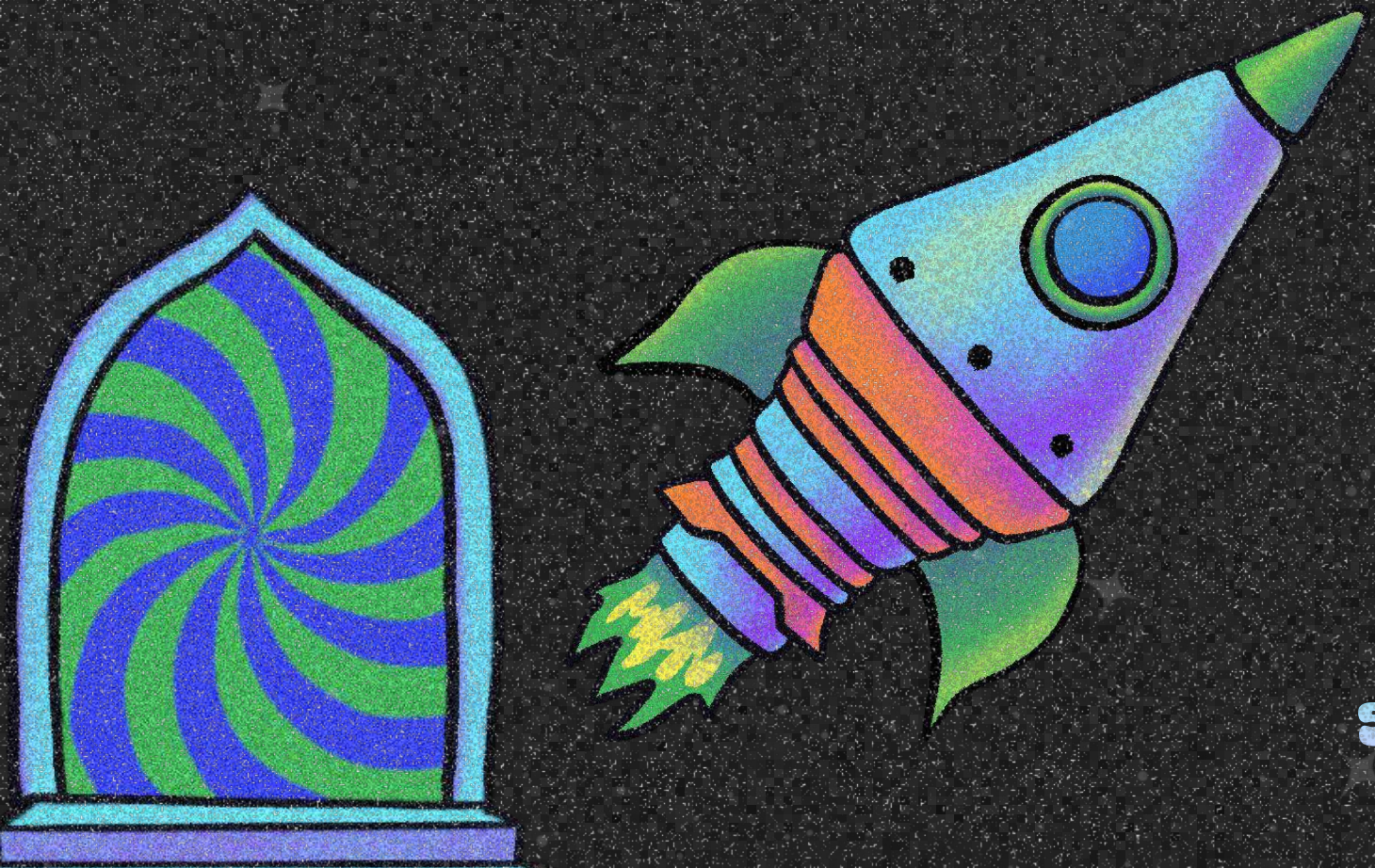
PRESALE AND STAKING
